million people with starvation and has already thrown over 8.5 million citizens on eminent famine alert. Water and electricity are scarce and are rationed three times a week, while the vast majority of our people are sick with malaria, HIV Aids, malnutrition and pandemic cholera, with a probable 50% level of unemployment, including the formal and the informal economic sector.
